ORDINANCE NO. 290

**AN ORDINANCE REQUIRING A BUSINESS LICENSE
FOR TRADES, BUSINESSES, OCCUPATIONS AND
PROFESSIONALS AND FEES FOR YARD SALES.**

BE IT ORDAINED BY THE CITY OF TAYLORSVILLE AS FOLLOWS:

Every entity whether an individual, proprietorship, partnership, company or corporation operating and/or conducting any type of trade, business, occupation or profession within the city limits of the City of Taylorsville, Kentucky, shall obtain a business license by July 1st of each year, said license to be valid through June 30th of the next proceeding year, for the fee set forth herein:

1. \$125.00 for each location of such entity, including contractors;
2. \$125.00 for each and all other such entities whether said entity has a business location within the city limits of the City of Taylorsville; entities shall include, door to door salesperson and such entities loading and unloading vehicles, etc.;
3. Any individual who has a yard sale shall pay \$5.00 per day, per location;
4. No business license shall be issued unless and until the aforesaid fees are paid and no entity shall engage in any trade, business, occupation or profession within the city limits of the City of Taylorsville, Kentucky, until a business license is issued;
5. Any entity which is in violation of this Ordinance shall be fined \$75.00 for the first day of the violation; and \$10.00 for each additional day, plus any court costs, with all fines and forfeitures to be paid to the City of Taylorsville;
6. All such licenses shall be issued and fees collected by the City Clerk or City Treasurer;
7. Ordinance No. 169 is hereby repealed;
8. This ordinance shall take effect from and after passage and publication;
